

## **Development Review**

Meeting Schedule | 2025

Concept Plan | Development Plan | Use on Review Special Use | Planned Development

Pre-application consultations are required for comprehensive plan amendments, concept plans, use on reviews, special uses, and development plans, beginning with the April 2025 applications.

- 1 Pre-application consultations shall occur at least seven days prior to the deadline for Planning Commission meeting application submittal and can take place in person, over the phone, or virtually depending on the nature of the request.
- 2 Pre-application consultations will occur on the first three Tuesdays of the month beginning at 9:00 AM and ending at approximately 10:30 AM for properties in the City of Knoxville and Knox County.
- 3 To be placed on the consultation meeting agenda, <u>complete the</u> <u>pre-application consultation</u> <u>form and submit it with proposed plan drawings to applications@knoxplanning.org</u> no later than the Friday before the date of the meeting you wish to attend. Planning will contact all applicants with the approximate time within the meeting their project will be discussed.

**Developer Meetings:** These meetings occur on <u>Wednesdays of the second week following the deadline day</u> of the applicable meeting. Planning will notify the applicant the Monday preceding the Developer Review meeting if they should attend and will provide the approximate time within the meeting their project will be discussed.

Revised plans should be submitted to the project planner as a pdf. This is also the date that any revised Transportation Impact Analysis should be submitted unless directed otherwise. (The original Transportation Impact Analysis must be submitted by the standard application deadline.)

#### **IMPORTANT NOTICES**

#### **FINAL Revised Plans:**

- 1. **FINAL Revised Plans:** This is the date that <u>final revisions of plans</u> need to be submitted to the Planning office. Earlier revisions will be due prior to this as provided by the planner in charge of reviewing the plans.
- 2. Further revisions needed after the final revision deadline may cause a postponement of the application.
- 3. Staff recommendations will be based on the revisions submitted by the final revision deadline. Staff reports will not be updated to reflect any changes made after this date.
