FROM THE EXECUTIVE DIRECTOR

Our work of the past year was driven by collaboration. We made it a priority to provide information and staff support to local partners and the community, seizing all opportunities to join the City of Knoxville, Knox County, and others to produce meaningful resources that tackle area challenges.

We continued to contribute to the county's first ever integrated land use and transportation plan. Called Advance Knox, the project should be completed later this year. We also provided resources to the City of Knoxville to finalize a Missing Middle Housing Scan, a look at the connections between zoning and innovative infill housing options. These projects are great examples of how local agencies have joined forces to make more informed, deliberate, and responsible decisions as growth continues.

Our transportation group had a similar focus on large-scale collaboration over the past year. They participated in a series of areawide transit studies with local service providers and oversaw a regional pavement management plan that will allow more costeffective maintenance for member jurisdictions. They also began work on a Regional Roadway Safety Action Plan, a joint effort to save lives and prevent injuries.

Behind the scenes, we continued to produce technical reports and data-access tools that help our staff and partners. We expanded the functionality of our case map viewer, updated maps showing priority populations, and continued providing web-related assistance for external agencies.

I am pleased to present this snapshot of our major accomplishments over the past year and hope you will read on to learn more. None of these accomplishments would be possible without the hard work and unwavering dedication of our staff. I am eager to see what the next 12 months hold as we continue to support our partners and lend expertise to find meaningful solutions to community challenges.



PLANNING COMMISSIONERS

The planning commission is an advisory board made up of 15 citizens seven appointed by the City Mayor and eight by the County Mayor.

These volunteers come from a variety of backgrounds, representing diverse community interests and concerns. They serve staggered four-year terms and may be re-appointed. The Commission meets the second Thursday of every month to make recommendations and take action on local development requests.

Executive Committee: On an annual basis, the Planning Commission Chair appoints an Executive Committee consisting of the Chair, Vice-Chair, and three other members of the Commission. Terms are one year in length.

The Executive Committee reviews and recommends the annual budget and work program, consults and advises on matters brought by the Executive Director, and resolves staff issues as needed.

PLANNING SERVICES

Planning Services staff guide residents, developers, and others through local review processes. Planners evaluate requests for rezonings, subdivisions, and development plans, and they prepare a recommendation for each case that will be considered by the Planning Commission.

The group updates sector plans and the general plan and conducts special studies, like park inventories, small area plans, and guidelines for neighborhood overlays. Staff also regulate the subdivision of all land in Knox County other than the Town of Farragut and maintain the county's property addressing system. Planning Services works closely with several city and county departments, as well as our own Transportation Planning division, promoting the interconnectivity of land use and transportation infrastructure.

Missing Middle

Planning collaborated with consultant Opticos, City of Knoxvlle, and Knoxville Area Association of Realtors on a Missing Middle Housing Scan. The report identifies barriers to innovative types of infill housing development in the city, as well as next steps to better accommodate them in the future. Since the report was released, city staff have engaged agency leadership, local partners, and City Council to find opportunities to bring these housing types to our community.

Advance Knox

Work on this comprehensive land use and transportation plan continued over the past year with public outreach focused on a preferred growth scenario, future land use map, and list of prioritized transportation projects. The final document is expected later this year.

Alcoa Highway

The Alcoa Highway Corridor Study was adopted by the Knoxville-Knox County Planning Commission, Knoxville City Council, and Knox County Commission last summer. The study looks at land uses and zoning along the corridor to determine changes needed to spur redevelopment and encourage retail, commercial, and housing investment.



TRANSPORTATION PLANNING

The Transportation Planning group supports the Knoxville Regional Transportation Planning Organization, or TPO, a federally-required board that coordinates road improvements, bicycle and pedestrian plans, freight movement, and transit.

Staff members collaborate with the Planning Services division on corridor studies, sector plans, and other land use planning activities, in addition to working closely with the engineering departments and transportation service providers of Knoxville, Knox County, and several surrounding communities.

Transportation Improvement Program

The FY 2023-2026 TIP was adopted by the TPO Executive Board in October to program funding for roadway, bridge, transit system, and bicycle and pedestrian projects. The TIP is a four-year work program of federally funded, regionally significant, and financially constrained transportation projects within the Knoxville Urban Area.

Pavement Management -

The TPO worked with Applied Pavement Technology, Inc. to assess pavement conditions for the cities of Knoxville, Oak Ridge, Maryville, and Clinton, as well as Blount County. The jurisdictions are now using that information to identify the streets most in need of repair and to develop multi-year maintenance and rehabilitation plans for cost-effective management of the region's road network.

Regional Roadway Safety Action Plan

The TPO has formed a task force with local government, TDOT, and Bike Walk Knoxville to identify changes that can be made in the Knoxville Region to save lives and prevent serious injuries on our roadways. The plan is expected to be finished in the summer and, once completed, will position the TPO and local governments to apply for federal funding.



INFORMATION SERVICES

This division comprises several support functions, including research, GIS, web development, graphic design, and communications. Staff assist agency-wide planning activities by conducting background research for plans and presentations, maintaining the print and digital library, and leading community outreach efforts.

Planning's geographic information systems (GIS) group maintains land and infrastructure data systems and produces maps. Web and design staff are responsible for content management and presentation of the many websites housed at Planning, and they prepare artwork and layouts for the agency's plans, reports, and brochures.

BOARDS AND COMMITTEES

Design Review Board

The Design Review Board examines proposals for private and public development in Knoxville's center city. This group also reviews applications for infill housing in Edgewood Park, Lonsdale, and Oakwood/Lincoln Park neighborhoods for conformance with the Heart of Knoxville Infill Housing Guidelines. The goal of the review board is to foster attractive and harmonious development and rehabilitation of the downtown area and to ensure infill development is architecturally compatible with established neighborhoods, fosters community stability, creates pedestrianoriented streets, and meets a wide range of housing needs.

Historic Zoning Commissions

The Historic Zoning Commissions for Knoxville and Knox County evaluate projects proposed in local Historic Overlay districts. Work of the commissions is intended to stabilize or improve property values by encouraging rehabilitation and new construction that is harmonious with the area. The commissions review applications to repair, alter, rehabilitate, relocate, or demolish properties; review proposed new construction; and identify properties for local or National Register of Historic Places designation.



Tennessee Technology Corridor Development Authority (TTCDA)

The Tennessee Technology Corridor Development Authority and its design guidelines ensure aesthetic quality and environmental conservation for developments within the Technology Overlay zones of the city and county.

TPO Executive Board and Technical Committee

The TPO Executive Board and Technical Committee work with TPO staff to make decisions on regional transportation plans and projects. The Executive Board, which sets policy and adopts plans, is made up of elected officials from the TPO planning area, representatives from the East Tennessee Development District, and the Governor of Tennessee. The Technical Committee consists of local planners and engineers who work closely with staff and make recommendations to the Executive Board.
