2301 Jefferson Avenue / Parcel ID 82 J U 023 – New accessory structure (11-E-21-HZ)

Discussion: Lindsay Crockett reviewed the staff report and staff recommendation of approval.

David Nix, 2413 E. Fifth Avenue, Edgewood-Park City Neighborhood Representative was present to provide comments from the neighborhood.

Tillman moved that the application submitted for 2301 Jefferson Avenue be approved as per staff recommendation with the addition that windows, garage door, and pedestrian door to be approved by staff, incorporating the board and batten siding.
