Knoxville Historic Zoning Commission Chair Rick Blackburn called the meeting to order at 8:31 a.m. Roll call was taken, and it was noted there was a city quorum. Comm. Blackburn stated that the meeting is being televised and recorded. He also asked that speakers limit their presentations to five minutes. Applicants or members of the public who wished to speak on an Agenda Item were sworn in. He further noted that any appeals to Commission decisions can be taken to Chancery Court if appealed within 60 days.

APPROVAL OF MINUTES

Action: Comm. Tillman moved to approve the June 15, 2023 Knoxville Historic Zoning Commission Minutes as presented. The Motion was seconded by Comm. Webster. The Motion carried unanimously 6-0.

RESULT: Approved

Comm. Blackburn notified the Commission that applicant Maik Lang of 424 E. Oklahoma Avenue (7-A-23-HZ) requested a postponement of 30 days. Comm. Randazzo made a motion, seconded by Comm. Eason, to postpone the application for 424 E Oklahoma Ave. (7-A-23-HZ) until next month's meeting, per the applicant's request. The Motion passed unanimously 6-0.

Exterior rehabilitation: window replacement (7-C-23-HZ)

Staff Recommendation:

Staff recommends approval of Certificate 7-C-23-HZ, subject to the following conditions:

- 1) additional information on the windows' condition to be submitted to staff, to confirm the windows warrant replacement;
- 2) replacement double-hung windows to feature a 6/1 pattern, with exterior muntins reflecting the depth and width of the originals instead of solely grid-between-the-glass;
- 3) revised specifications to be submitted to staff reflecting condition 2 and any additional items identified by the Commission.

Discussion: Lindsay Crockett reviewed the staff report and staff recommendation of approval.

Applicant Harry Boston, 1202 Luttrell St., Knoxville, TN 37917, and contractor Roger Sayers, 1705 Mountain Lake Ln., Knoxville, TN 37922, were present to discuss the application for review. There was no opposition present. Arin Streeter, on behalf of the Fourth and Gill Neighborhood Association, submitted a statement to the Commission regarding the neighborhood's support of staff recommendations.

Action: Comm. Tillman moved that the application for 1202 Luttrell St. (7-C-23-HZ) be postponed until the August 17, 2023, meeting to allow the applicant time to provide the Commission with documentation on the condition of all 13 windows to be replaced. The motion was seconded by Comm. Eason. The motion carried 4-3; Comm. Blackburn, Comm. Mitchell, and Comm. Randazzo voting no.
