# **Knoxville Certificates of Appropriateness**

Fourth and Gill H 616 Luttrell St. / Parcel ID 94 D F 006 Exterior rehabilitation (9-D-23-HZ)

**Staff Recommendation:** Staff recommends postponement of Certificate 9-D-23-HZ, allowing the applicant to provide a revised design that more clearly indicates the building's historic evolution. The Commission should discuss the proposed fiber cement lap siding and windows.

#### **Discussion:** Lindsay Crocket reviewed the application and the staff recommendations.

Applicant Jeff Talman, 616 Luttrell St., Knoxville, TN 37917, and architect Susanne Tarovella, 2908 Sevier Ave., Knoxville, TN 37920, were present to discuss the application for review. Melinda Whetsel, 1015 Luttrell St., Knoxville, TN 37917, spoke in support of postponement. Fourth and Gill Neighborhood representative Arin Streeter submitted a comment in support of staff's recommendation for postponement that was read aloud by Lindsay Crockett.

#### A motion was made by Comm. Tillman and seconded by Comm. Eason to postpone certificate 9-D-23-HZ until the October 19, 2023 meeting. The motion carried unanimously, 7-0.

Old North Knoxville H 1339 Grainger Ave. / Parcel ID 81 E E 046 Rear porch addition (9-B-23-HZ)

**Staff Recommendation:** Staff recommends approval of Certificate 9-B-23-HZ, subject to the following conditions: 1) applicant to submit railing detail to staff for approval; 2) final site plan to show deck meeting all relevant elements of base zoning code.
