Update to Knoxville’s One Year Plan

Knoxville, Tennessee – January 18, 2018 – The annual update of the City of Knoxville’s One Year Plan has begun, and the public is encouraged to participate. The One Year Plan serves as the foundation for zoning decisions and is based on the land-use goals, objectives, and policies found in the City’s long-range plans.

Along with the plan update, slope and stream protection areas within the North City and West City Planning Sectors, including portions of unincorporated Knox County, will be revised.

Three meetings have been scheduled to give community members the opportunity to review and discuss recommended changes to the One Year Plan and slope and stream protection areas:

Knoxville-Knox County Metropolitan Planning Commission

The Metropolitan Planning Commission (MPC) was established in 1956 by Knoxville and Knox County as the agency responsible for comprehensive county-wide planning and administration of zoning and land subdivision regulations and remains so today (except for the town of Farragut). Funding for MPC activities comes primarily from city and county appropriations and from federal grants for specific studies. The Commission prepares and adopts a general plan, reviews subdivision regulations and site plans, prepares and recommends zoning ordinances and maps to the Knox County Commission and Knoxville City Council, reviews proposed zoning amendments, and prepares a capital improvements plan for the City of Knoxville.
