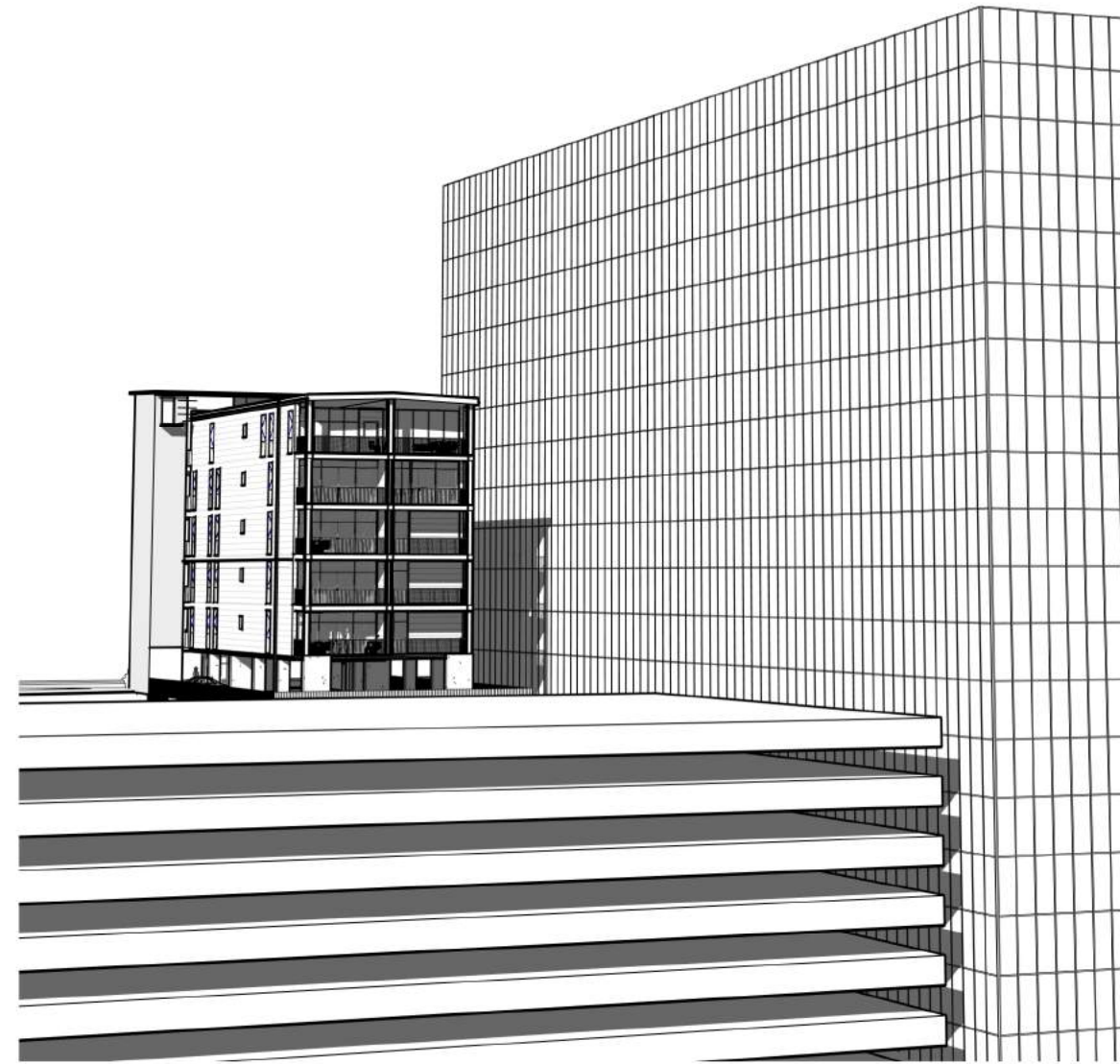

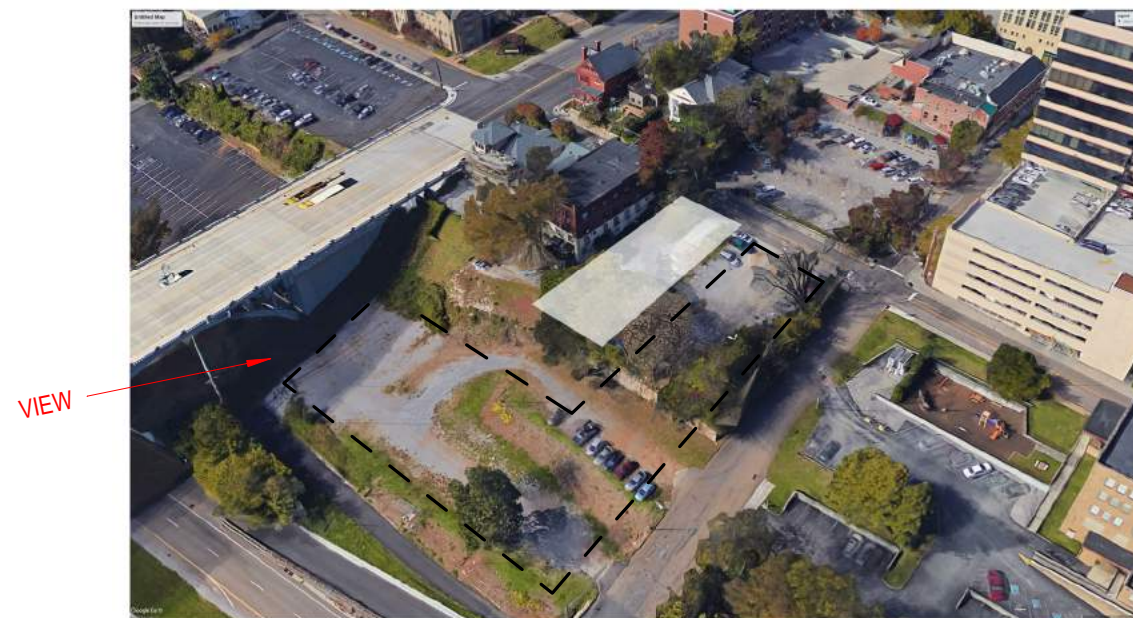
① 3D - Henley St Bridge - Overlook Open (Preferred Option)

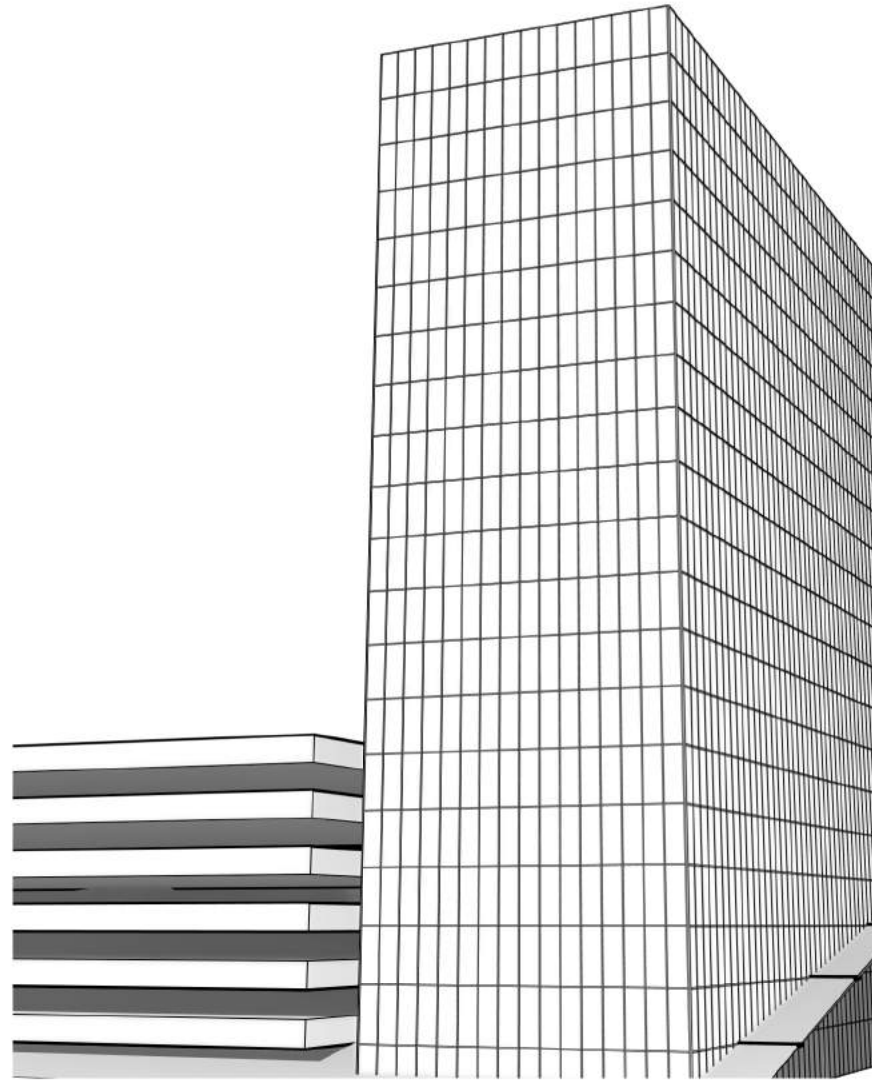

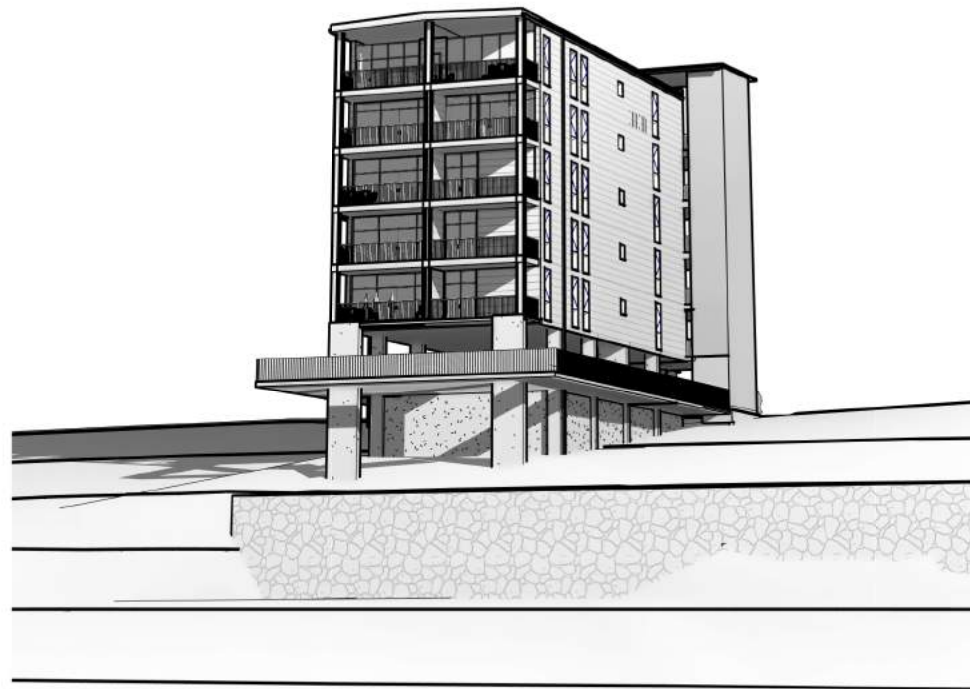
