# Certificate No. 6-A-17-DT

**Discussion:** Mike Reynolds reviewed the submittal and staff recommendation. He noted that the Applicant has agreed to work with his sign company to address the square edges, perhaps with some clear protective edging to the bottom of the sign. Applicant Stanton Webster was present and had nothing further to add to the staff report. After a brief discussion it was clarified that since there is a 5 inch lip of brick along the bottom of the wall that protrudes out along the façade where the sign would be placed the sign would meet code as proposed. It was however suggested that the Applicant round the lower corners of the sign from a safety perspective.
