800 S Central St – Theatre Knoxville (Brian Ewers)

Pre-development meeting: N/A

Discussion: Mike Reynolds reviewed the submittal and staff recommendation. The project consists of renovation of a former church building located at 800 S. Central Street into a theatre. The renovation will include removal of church related and other architectural accents, cleaning and repairing existing windows and façade, installing new vertical cladding, awning, front door, and sign on the front elevation. The proposal will incorporate the emergency egress on the north side of the building that the board approved in

September 2018. Staff recommends approval subject to the following conditions: 1) Installation of the bicycle parking shall meet the minimum standards of the City of Knoxville Zoning Ordinance. The revised bicycle parking plan shall be reviewed and approved by DDRB staff.

Brian Ewers, Dollar and Ewers Architecture, Inc., 111 E. Jackson Avenue, introduced himself to the Board and made himself available for questioning. Mr. Ewers explained that accommodating bicycle parking is not a problem and he is in agreement with staff recommendation. Mr. Ewers went on to explain that the goal is to warm the front façade of the building with fiber-cement simulated wood as the building is currently constructed of concrete block.

Kaye Graybeal, Knoxville Knox-County MPC, had a few questions in regards to exterior surface materials. Mr. Ewers responded by stating that the simulated wood grain will have a smooth finish. The front entrance door will be a custom solid wood door, and all materials used will meet the fire district standards.

A Motion was made by Comm. John Thurman and seconded by Comm. Robin Thomas to recommend approval of Certificate No. 10-A-18-DT as submitted and per staff recommendation. The Motion carried unanimously.
