418 E. Oldham Avenue / Parcel 81 L A 012 – Bentley Marlow 416 & 418 LLC

2504 Harvey Street / Parcel 81 F B 044 - David Kerns

Discussion: Lindsay Crockett reviewed the submittal and staff recommendation.

Staff Recommendation:

APPROVE Certificate 5-A-21-IH, with the following conditions:

- 1) Modify front setback to be more consistent with adjacent properties;
- 2) Add a walkway from the front door to the sidewalk;
- 3) Parking to meet City Engineering requirements (including modified placement on west side of lot);
- 4) Verify foundation height to be consistent with historic properties;
- 5) Locate an additional window on the right elevation and omit non-operable façade shutters;
- 6) Exterior siding to be lap siding with an overlap instead of Dutch lap or flush panels;
- 7) Incorporate one native or naturalized tree in both front and rear yards.

A Motion was made by Comm. Foster and seconded by Comm. Natour to approve Certificate No. 5-A-21-IH subject to 7 conditions, per staff recommendation.

A roll call vote was taken. The motion carried unanimously 8-0.

Staff recommends approval of Certificate 5-D-21-IH, with the following conditions:

- 1) Parking to meet City Engineering requirements;
- 2) Verify foundation height to be consistent with adjacent houses;
- 3) Porch posts to measure 6" by 6" or larger;
- 4) Additional windows to be placed on right elevation, along with appropriately sized trim surrounding all windows,

with approval by staff;

5) Use lap siding with an overlap instead of Dutch lap or flush panel siding.

A Motion was made by Comm. Childress and seconded by Comm. Foster to approve Certificate No. 5-D-21-IH subject to 5 conditions, per staff recommendation.

A roll call vote was taken. The motion carried unanimously 8-0.
